

Teen Impact TV Submission Form

I have contributed to the production of, I appear in, and/or my voice is heard in the videotape submitted herewith (the "Submission") for consideration by Teen Impact TV for possible inclusion in the television program or web site under Teen Impacts control. In consideration of the possibility of Teen Impact TV broadcasting the Submission or parts thereof, I hereby agree as follows:

1. I irrevocably grant to Teen Impact TV, its successors, licensees and assigns, the right to use, edit, modify, alter, portray, broadcast, exhibit and distribute my name, voice, likeness, photograph, image and biographical information in and in connection with the Program and any and all promotion, advertising, marketing, merchandising, publicity and any other ancillary uses thereof, in any and all media now known or hereafter devised throughout the universe in perpetuity.

2. I irrevocably grant to Teen Impact TV, its successors, licensees and assigns, the right to use, edit, modify, alter, portray, broadcast, exhibit and distribute the Submission and any and all matter, materials, ideas, dialogue, writings, artwork, photography, audiovisual works, scenes, routines, choreography, musical compositions, sound recordings and/or other contributions or property of any kind (whether or not copyrightable) that I have made or created in connection with the Submission, in and in connection with the Program and any and all promotion, advertising, marketing, merchandising, publicity and any other ancillary uses thereof, in any and all manners, media and formats now known or hereafter devised throughout the universe in perpetuity.

3. I accept, agree to and acknowledge the following: (i) Teen Impact TV is not obligated to return the Submission; (ii) there does not now exist, nor has there ever existed, nor will there exist, a fiduciary relationship between me and Teen Impact TV; (iii) I am granting the rights granted herein on a voluntarily and unsolicited basis; (iv) Teen Impact TV is not obligated to watch, review or consider the Submission; (v) in no event shall I receive any monetary or other compensation in connection with the Submission or the Program; and (vi) the decision whether to use the Submission or any part thereof in the Program is within Teen Impact TV's sole and absolute discretion.

4. Teen Impact TV, its parent and related companies, subsidiaries, affiliates, divisions, and their past, present, and future directors, officers, agents, representatives, employees, contractors, partners, shareholders, members, successors, and assigns shall not be liable for any liabilities, claims, demands, losses, damages, costs, or penalties of any kind arising out of or relating to the Submission (including, without limitation, in the event of any injury, illness, damage, loss or harm to me or any other person or animal, or to my or any other person's property, or my death, howsoever caused, resulting or arising out of or in connection with the Submission or the production thereof) (collectively "Submission Claims"). I, along with my children, spouse, parents/guardians, executors, administrators, successors and assigns, hereby irrevocably release the Teen Impact TV Parties from any and all liability and will not sue or claim against the Teen Impact TV Parties in connection with the Submission Claims. I agree to indemnify, defend and hold harmless the Teen Impact TV Parties from and against any and all Submission Claims.

5. I represent and warrant that: (i) I own all material(s) that I have contributed to or created in connection with the Submission; (ii) I was not and am not an agent of Teen Impact TV and was not and am not acting on behalf of or as a representative of Teen Impact TV in connection with the Submission; (iii) neither the Submission nor any part thereof will infringe any rights of any third party (including without limitation rights of copyright,

trademark, rights of privacy, and rights of publicity); (iv) I am not a member of the Screen Actors Guild (SAG) or the American Federation of Television and Radio Artists (AFTRA); and (v) **I did not engage in any of the following in connection with the production of, my appearance in or my contribution(s) to the Submission: infliction of injury to any person or animal, humiliation of any person (whether public or private), infliction of emotional distress on any person, assault or battery of any person, damage to any property without permission, entry on any property without permission, or any other act or omission that could give rise to civil and/or criminal liability.**

6. Teen Impact TV may assign this agreement or license its rights hereunder, in whole or in part, to any person or entity. In no event shall I be entitled to revoke, rescind or terminate any of the rights granted herein, nor shall I be entitled to restrain, enjoin or interfere with the production, distribution, exhibition and/or other exploitation of the Program. This release constitutes the entire understanding and agreement between me and Teen Impact TV, and supersedes all prior understandings, whether written or oral. The invalidity of any provision hereof shall not affect the remaining provisions, which shall be treated as severable and independent. This release shall be governed by the laws of the State of Utah (without regard to its conflicts of law rules).

7. I have not executed this release in reliance upon any representation or promise, whether written or oral.
